#### 3. Policy on School Planning Councils

#### Whereas:

Bill 11 (Education Statues Amendment Act, 2015) removed references to achievement contracts, superintendents' reports on student achievement and school planning councils from the School Act, effective July 1, 2015, relevant sections include the following:

- Section 2(a) of Bill 11 removed the definitions of "achievement contract" and "school planning council" from section 1 of the *School Act*.
- Section 7 repealed sections 8.1 and 8.2 of the Act (which provided for the establishment and set out the responsibilities of school planning councils).
- Section 13 replaced "school planning council" with "parents' advisory council" in section 74.01(1) and (2) of the Act (which provide for the operation of video surveillance cameras in schools).
- Section 14 repealed section 79.2 (achievement contracts) and 79.3 (superintendent's reports on student achievement).
- Section 15 replaced "school planning council" with "parents' advisory council" in section 82.1 (which provides for the establishment of specialty academies).
- Section 30(a) repealed section 168(2)(r) (ministerial orders respecting achievement contracts).

# 1. BCSTA (FV Branch) Report

Trustee Koopman shared the district report that was presented at the Fraser Valley Branch meeting in October.

#### 2. ProD Committee Report

The Superintendent reported on the District ProD Day scheduled for Feb. 18 & 19, 2016 at AESS. The theme for the SD#78 and Native Ed Professional Development Day is: Respecting the Spirit. Key note speaker is Dr. Gwen Point.

# 3. Strong Start / Head Start meeting

The Superintendent reported that elements of existing programs (Strong Start, Head Start, and Family Place) were pulled together with First Nations culture entwined. Sessions could rotate between the communities of Spuzzum, Boston Bar, and Boothroyd.

#### 4. Facilities Review / Strategic Facilities Plan

The Chair referred to the link that refers to Maple Ridge School District's Facilities Plan. The Secretary-Treasurer confirms that SD78 is also looking into a long term facilities plan.

#### 5. Curriculum Framework / Implementation

The Superintendent reported that MOE is implementing a curriculum change. Instructional hours have been reduced by 2 school days. 8 teachers from SD78 have been allocated to train and attend sessions about the new curriculum and assist in the planning of the 2 in-service days.

#### Whereas:

The BC Ministry of Education has revised curriculum for kindergarten to grade 9 and is in the process of revising grades 10-12. In order to implement these changes, the minimum number of instructional hours has been reduced by two days for the current 2015-2016 school year. The new non-instructional time will be used for the purpose of enabling teachers to participate in discussion and activities related to the implementation of the new curriculum.

# 9. Technology Committee Report

The Chair reported that the NGN (Next Generation Network) is ahead of schedule and will be up and running soon. Issues with MyEd BC continue on and report card time will be a crucial test for the system. The new Social Media policy was presented to the committee and discussion was had regarding portable drives being used as back-ups and how they should be encrypted when taken out of a secure building.

Discussion was had regarding the wifi letter emailed to Trustees. The Chair reports that this letter is on the agenda for the next board meeting and that the writer will be advised.

#### 10. Student Data

The Superintendent shared information on student data including bus manifests in the Agassiz-Harrison end of the district. A slight revision to route #5 is that there are 56 riders (rather than 58) arriving at AESS. The Transportation Dept. is doing what they can to accommodate all riders.
