G. REMARKS

1. Superintendent

a) Principals'/Vice-Principals' Meeting

The Superintendent reported that the following items were reviewed: administrators' handbook, district data, district numeracy assessment, and Framework for Enhancing Student Learning. Of concern with the data is the decline in the 6 year completion rates for First Nation students.

2. Secretary-Treasurer

3. Assistant Superintendent

a) Healthy Communities Committees

The Assistant Superintendent reported that Fraser Health's Child and Youth Crisis Program has changed its name and how youth and families can access mental health crisis support. Now called the START Team, the focus remains the same – providing assessment and intervention services for 6 – 18 year olds experiencing a mental health crisis.

b) Cameras on Buses

The Assistant Superintendent reported on side-view cameras on buses that activate when the arms are out. Chilliwack School District is currently using these as a pilot project. There are potentially 3 buses in SD#78 on which these cameras could be useful.

c) Qingdao Students

The Assistant Superintendent reported that the students should be arriving at the end of the month; however they are still waiting on their visas.

d) Grade 6 Exit Interviews

The Assistant Superintendent has created a transition survey. Further information is required as to who is to be interviewed (and for what reason), and how the results can be utilized.

Concern was raised that there is a high number of students on waitlists for Chilliwack schools.

3. Boundary Catchment Area Review Update

Trustee Koopman reported that 3 public forums have now taken place (including a survey) and all scenarios have been considered.

The Boundary Review Committee has a recommendation prepared to present at the next Board of Education meeting; that in September 2016, K-6 students attend Silver Creek and Coquihalla Elementary and all Grade 7 students attend Hope Secondary.

Advantages to having Grade 7s at HSS include: addresses competition for attendance at desired school; consistency across the district; improved programming options at HSS; space available at HSS; and potential district events across communities.

Disadvantage to having Grade 7s at HSS include: perhaps lack of leadership opportunities for grade 7 students; survey results 60% of parents who completed survey wanted K-7 (16% returned); parental concern for some students at the high school; and 54% of students wanted to attend grade 7 at Elementary.

Concern was raised on the process the board has gone through with regards to the Boundary Review Committee.

The Secretary-Treasurer also indicated: number of special needs students and the room needed at Coquihalla does not allow space for the Grade 7s; splitting the Grade 7s could be a disadvantage and not in the best interest of the student; and staffing implications would be more difficult. Enrollment has changed since 2014 and once the catchment areas are reviewed, this will be reviewed again.

Trustee Hendrickson left the meeting at 9:25 and returned at 9:27

4. District & Native Ed ProD Day

The Superintendent reported that registration is still open for the Feb. 18/19 event. The key note speaker is Dr. Gwen Point.

5. Kent Elementary Field Trip

The Superintendent reported that the field trip for swimming and skating at the Hope Rec Centre was approved prior to the board meeting due to low risk.

6. BCSTA Provincial Council

Trustee Johnstone reported that BCSTA Provincial Council is Feb. 20th. The theme of the Issues Forum is: Audits and Their Implications for Boards of Education.

7. BCPSEA Rep Report

The Chair shared information from the BCPSEA AGM in January which included: Ideas for Bargaining in 2019; Student Population Growth; Looking Ahead (Deputy Minister, Dave Byng): Ethics Survey from the Office of the Auditor-General: Performance Management Pilot Project; and Shared Services.
