Suggestions came forward such as: round table discussion questions; include all partner groups (including public); include the whole district; electronic option to participate; include facilitator; and rotate annually at each end of the District.

Questions that followed were: how to get the message out; what types of questions to ask; who could facilitate (Board Chair vs Independent); and timelines as to when this could happen (preferably by the end of the school year).

G. REMARKS

1. Superintendent

a) Principals'/Vice-Principals' Meeting

The Superintendent shared highlights of the March and April meetings that included: the review of Policy 5020 (Curricular, Extra Curricular Activates);

Framework for Enhancing Student Learning (Planning Process); review of occupational therapy and physiotherapy services; Calm, Alert, and Learning (CALM) program; Roots of Empathy; and guest speaker (Tom Hierck): Starting a Movement (building culture from the inside out in professional learning communities).

2. Secretary-Treasurer

a) MOE School Preservation Program

The Secretary-Treasurer reported that the School Preservation Program is the new name for the Routine Capital Program (which funded the recent projects at Kent and Silver Creek Elementary schools). Only projects over \$100,000.00 are eligible. These are project that would not typically be supported by the Annual Facilities Grant.

b) Budget 2016/2017

The Secretary-Treasurer reported that notification of funding was received in March. There was an additional allocation of \$86,000.00 due to advocacy of School District 78 partner groups. With enrollment remaining stable, layoffs have been minimal. Final approved budget is due to the Ministry by June 30th.

The Secretary-Treasurer explained that September 30th is the snapshot date for enrollment, and now with the end of funding protection, enrollment will impact the amount of funding received. The difference in the increase in costs vs the increase in funding is manageable. Programming has remained stable due to the surplus. NGN costs, MyEdBC, and exempt staff/management increases must be absorbed by existing budgets. Government has promised to increase funding provincially for any students over current enrolment. A plan was sent in to the Ministry to show how School District 78 will generate the required administrative savings of \$209,600.00, which include: the closure of CE Barry, decrease in utility costs, and reduced WCB rates.

The Secretary-Treasurer stated that the injection of new funds covers the costs that are not covered by the Ministry, leaving School District 78 with a stable budget.

Due to the time, the Chair called for item J (Public Participation) as the next agenda item.

3. Assistant Superintendent

a) <u>CYMHSU Collaborative (Child & Youth Mental Health and Substance Use) –</u> Fraser Cascade Local Action Team

The Assistant Superintendent reported that he is the Chair of this local action team that has a budget of \$130,000.00 from various sources which is managed through a division of Family Practice. The local action team is made up of MCFD, school district community services, First Nation representation, nurse practitioners, physicians, psychiatrists, and other community members. Learning Lunches is where representative from the organizations get together around a topic in which experts come in to discuss.

H. INFORMATION

1. Retirement Dinner

The Superintendent reported that the Annual Retirement Dinner will take place on June 28th at 5:00pm at the Hope Golf & Country Club.

2. BCSTA Provincial Council Report

Trustee Johnstone reported that the Office of the Attorney General attended the Provincial Council meeting in February to discuss audits, their purpose, and the impact they have on school districts. A letter from BDSTA CEO Mike Roberts was read by Trustee Johnstone with regards to an external policy issue of the cutting of administration in schools and board offices.

3. Shoulder Tappers Program (Grant)

The Superintendent reported that a grant of \$25,000.00 was received by the Province to support students and increase programming capacity in the District. These funds can be used for a variety of opportunities such as employee fairs, northern experiences, etc.

4. Fraser Valley (FV) Branch Meeting

The Chair reported that she has been acting as the School District 78 representative at FV Branch meetings. Item 2.c. of the Constitution & Bylaws of the FV Branch were brought to her attention at the last Branch meeting that Trustee Tustian is to be the School District 78 representative (as she is the Education Committee Chair of the FV Branch).

Discussion ensued as to who is responsible for the preparation, distribution and approval of the FV Branch submission.

5. Student Leadership Conference Invitation

The Superintendent shared an invitation to the Board for the Student Leadership Conference coming up on May 25th. RSVP's are required by May 11th.

- AESS does an annual presentation on Pacer Day and is also addressed in Grade 8 and 10 Planning;
- Hope Secondary includes internet safety in their curriculum and is also bringing in a guest speaker from Safer Schools to address students (an evening session will also be provided for parents);
- ACE is joining AESS for Pacer Day, a community health nurse and substance abuse worker is brought in to speak to students, and they include internet safety as in-school sessions in their curriculum;

- TREC has certain sites that are blocked and will join Hope Secondary for their in-service, they have annual presentations, and a nurse practitioner has spoken to students in February;
- BBES had guest speaker do a presentation to school (students and staff).

The Assistant Superintendent reported that the elementary schools handle internet safety through their curriculum and are interested in participating in other school events.

7. Committee of the Whole (School Growth Plans)

The Chair reported that due to the changes in Ministry guidelines, the School Growth Plans no longer have neither a deadline nor a need for approval of the Board. ACE and TREC will be presenting their plans before the end of the school year.

8. Community Food Security Assessment

The Superintendent has met with the Hope Community Food Coalition who are looking at doing a Community Food Assessment. This group will be meeting informally with Principals and Teachers in Hope to determine what creative means are currently in place for providing food for students. They would also attend PAC meetings and are requesting space in a couple of schools to host events to seek feedback.
