# B. EDUCATIONAL HIGHLIGHTS (Two Rivers Education Centre - TREC)

Principal **Margaret Smiley** shared the makeup of the student body (74) at TREC which includes both referrals and adults, the youngest being 13 and the oldest 48. The Fraser-Cascade Continuing Ed is a new program that looks after the adult population and helps with funding. The Excel program (exclusive to TREC) is a special program for the highest risk students. There are 10 students expected to receive their Dogwoods in June, the highest number ever.

TREC is working closely with community partners: Free Rein & Associates; Child & Youth Mental Health; and Ministry of Child & Family Development. Income from other sources include: Tutoring Program from AEC; Fruit & Veggies Program; Breakfast for Learning; and the Honour your Health Grant.

TREC is the recipient of the CE Barry House Post. The raising of this post will take place on the morning of June 7<sup>th</sup>.
