- 2) Discover and encourage best practice of education instruction
- 3) Support staff, students, parents, and guardians through awareness

G. REMARKS

1. Superintendent

a) BC Liquor Distribution Branch Dry Grad Fundraising

The Superintendent reported that \$1,775.00 has been assigned by the Liquor Distribution Branch (LDB) toward dry grad events for schools in the District.

It was suggested that a thank-you card be sent to the LDB.

b) Work-to-Wellness

The Superintendent reported that reps from each employee group throughout the District attended an all-day session on May 4th that focused on harassment and bullying in the workplace and mental health.

2. Secretary-Treasurer

a) Benefit Renewals (PEBT & BCPSEA)

The Secretary-Treasurer shared information on the renewal of the benefit programs, of which there is a slight increase in monthly costs.

3. Assistant Superintendent

a) Local Action Team (CYMHSA)

The Assistant Superintendent updated the Board on training and co-facilitation of experiences the Local Action Team is involved in. The legacy they wish to leave

behind once the funding is depleted is an area-wide protocol for service provision across the School District, community agencies, physician offices, first responders, and hospitals.

b) P/VP Meeting Highlights

The Assistant Superintendent reported that the meeting included a tour of BBES. Topics of discussion included: Community Forum; Special Education; management of TTOCs; District Challenges; and Psych Ed Assessments.

H. INFORMATION

1. BCASBO Conference

The Secretary-Treasurer stated that the theme of the conference was "Innovation". The Finance Minister announced that \$25 million in funding will be returned to School Districts (which had been taken away in the past) by way of not charging for certain fees ie: PLNet and a portion of the NGN costs.

2. MOE Announcement: Graduation Program & Assessment

The Superintendent reported that in the 2016/17 school year, changes to graduation and assessment will be more closely aligned with the new curriculum and personalized learning. Some highlights of the announcement include:

- Credit requirements for Graduation Years will remain the same while the Provincial Assessment now focuses on Literacy and Math Skills
- Classroom Assessments will replace provincial exams for Science 10 and Social Studies 11
- Career Education Courses will be required in 2017/18 replacing Planning 10 and Grad Transitions

The Superintendent advised the Board that letters from the Ministry will be forwarded to all parents from the Principals.

Discussion ensued regarding the lack of provincial examinations and the possible lowering of standards. There were also concerns raised about entrance exams to universities and the possibility of students having to upgrade.
