H. REMARKS

1. Superintendent

a) Peter MacDougall (Ambassador to Hashemite Kingdom of Jordan)

The Superintendent reported that Peter MacDougal (former graduate from BBES – 1976) has been appointed Ambassador to Hashemite Kingdom of Jordan by The Minister of Foreign Affairs.

b) MOE Update

The Superintendent shared some of the highlights from the Ministry including: increase in student enrollment; future investments in rural education and transportation; strategic plan; official curriculum of K-9; and draft curriculum from 10-12.

The new FSA is ready for trial this fall with the current FSA being used for the final time in Jan/Feb 2017. Grade 10-11 provincial exams have been discontinued and replaced by classroom assessments. As School District 78 is following the revised Ministry K-9 Reporting Order, no new policy is required by the Board of Education. The Ministry will be reaching out to parents for feedback.

c) Early Childhood Education Committee

The Superintendent spoke about the speech and language services available to Kindergarten and Pre-school students. The Committee is sourcing a grant to help improve EDI scores as well as submitting an application to Fraser Health to support a satellite office in Hope with a Health Services Coordinator to improve access to services for children & families. There is a joint initiative between Yale First Nation, Hope Community Services, and Success by Six to support transportation for First Nation families to attend Family Place, Mother Goose and Strong Start.

d) Learning Improvement Fund (LIF)

The Superintendent explained that the purpose of the LIF is to address high learning improvement issues. The allotted funds for School District 78 (Fraser-Cascade) are \$385,845.00 for 2016-2017. The Superintendent requested that the LIF Spending Plan be shared with the Board via email or Special meeting in order to post the necessary positions in a timely manner.
