2. Public Apology

The chair reported that disparaging comments were made over a year ago by a trustee of the board to a school district employee in which a public apology was expected. A letter of apology was written on behalf of the board. As the trustee was not in attendance (and the employee was), the chair made the following statement:

"Some time ago, at a public meeting like this, comments were made by a Trustee of the Board which called into question the integrity and competence of one of our District employees, Mr. Dan Landrath. I do not want to repeat what was said, as the statements were untrue, as well as unfair to Mr. Landrath. They related to his work in overseeing our school busing system, and impugned his integrity and competence.

Some months ago, on behalf of the Board, I wrote to Mr. Landrath to apologize for the comments which were made, expressing our support for him and our appreciation of his good work on behalf of the District. With his consent, and in light of the fact that the improper comments were made at a public meeting, we believe it is appropriate that an apology also be made publicly.

The Board is committed to providing our employees with a work environment which respects their dignity and privacy. Public statements which are false and disparage the work of our employees are not consistent with this commitment. I would like to publicly apologize to Mr. Landrath for the hurt and embarrassment caused to him by the actions of a trustee of this Board.

We regret that these statements were made, and wish to make it clear that the Board has complete confidence in Mr. Landrath's professionalism, competence, and integrity. We appreciate the work he does for the District and our students, and thank him for his service."

Discussion ensued regarding the cost of the investigation and legal fees to date which were stated at being close to \$55,000.00.
